What do I need to know?

Entry

All 2020 Beauty Awards entries must be submitted online by September 29, 2019 (late deadline October 25, 2019 – additional fee applied).

CEW does not accept submissions for the Best Seller Award and QVC Beauty Quest.

Participation

Participation in the Product Demonstration on Thursday, February 27 is **OPTIONAL**.

All approved entries submitted have the option to participate in the Product Demo.

With over 2,000 attendees, this event gives members the chance to experience the entries, both at an exhibit area and in the product demonstration gift bag, helping to inform their vote. Entries who choose not to participate, may still submit product for the gift bag.

In addition, the setup of the event will be by Product Company/Brand NOT by category. This gives companies the option to have **one Demonstrator** for every **two product entries** or **one Demonstrator max for each individual product entry**.

There are about 2,200 attendees at the Product Demo and they are testing the products. You would need to use your discretion on the quantity of products/handouts to bring in order to accommodate the demonstration. Please note that not everyone gets to go to every table, so you can anticipate 1/3 will pass by your table at minimum.

PRODUCT DEMONSTRATION GIFT BAG

Why should I submit product in the Demonstration Gift Bag?

Participating in the Demonstration Gift Bag is an excellent way to showcase your product to CEW members, beauty industry professionals who comprise the Finalist voting panel. While participation is not required, most companies who enter the Beauty Insider Awards choose to submit in the Demonstration gift bag.

In order to ensure the fair and equal distribution of products, sampling will NOT be permitted at the individual product stations.

NOTE:

- All deliveries to the fulfillment house **MUST** be properly labeled as above.
- All truck deliveries must be delivered on a pallet (if products fill more than 1/2 pallet).
- CEW cannot be responsible for items that are not included in the goody bag due to mislabeling.
- All shipments must have a packing slip; this is the detailed information of what the boxes contain.
- All Products sent to the Fulfillment house will be inserted into the gift bag exactly as received; ie: any price tags or outer wrap will remain on the product unless removed before shipping.
- Can submit full, sample or trial size products. **CANNOT** submit marketing materials about the products.

Someone else is demonstrating my product, what should they bring?

Please have them bring photo ID, the product name, company & category & contact name. Demonstrators will not be permitted to enter without this information.

Can a demonstrator switch out with another demonstrator?

Demonstrators will NOT be allowed to switch out with other demonstrators. Demonstrators at the event found to not have the Demonstrator Badge & wristband will be escorted from the building, *No Exceptions*.

How can a demonstrator receive a gift bag?

In order for a Demonstrator to receive a gift bag, they **must be** a CEW member and purchase a ticket. At the end of the event, demonstrators that have a purchased ticket can collect their gift bag.

What is the cancellation policy for the Product Demo?

If you are confirmed to participate in the Product Demonstration portion of the Beauty Awards and cancel your participation refund will not be issued. . All written cancellations must be sent to Events Team at beautyawards@cew.org.

If you are confirmed to participate in the Product Demonstration portion of the Beauty Awards and your Demonstrator is not present on event day by 4:30 pm, EST, a refund will not be issued. ..

A written copy of the Beauty Awards Demonstrator Cancellation Policy is available on request.

SETUP INFORMATION

Can I have more than one setup person?

Each product entered can have up to 2 set-up personnel, however, all non-demonstrating personnel will be asked to leave the premises at the close of Setup Period 1 (12-2:00PM) NO EXCEPTIONS.

I have more than one product being demonstrated - will they be next to each other?

Entries will be organized by Product Company/Brand not by category. All entries for one brand will be together. We require a minimum of one Demonstrator for every two product entries or one Demonstrator max for each individual product entry. Indie and Eco entries will be in a different room and organized by company name.

SHIPPING/STORAGE

Pre-Event

Demonstrators **may not** ship any materials to the Metropolitan Pavilion ahead of time. All exhibitor materials must be carried in during the specified SETUP PERIOD(S). The **only** shipments permitted to the venue are floral arrangements.

Floral arrangements may be shipped to the below address and **MUST** be properly labeled or they will not be refused for delivery:

Any shipments of supplies/setup materials other than floral arrangements will be refused.

Post Event

Demonstrators are not permitted to leave any items to be picked up at the venue by a messenger or shipping service.

Demonstrators needing assistance in removing exhibit items must arrange assistance for pickup at the close of the show beginning at 8:00PM.

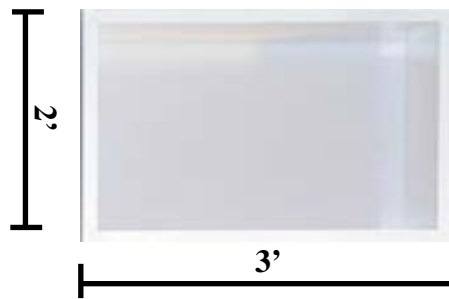
Any items left on the display table at the end of the evening will be discarded.

Storage

Storage of supplies/setup materials is limited to the space underneath your table. There will be no additional storage on site for demonstrator use.

DISPLAY RULES/REGULATIONS

- The Demonstrator must check in with CEW Staff upon arrival at the space
- Setup of the demonstration area must take place during either or both Setup Periods
 - 12:00-2:00 PM – SETUP PERIOD 1
 - Demonstrator and setup team permitted
 - 3:00 PM – 4:00 PM – SETUP PERIOD 2
 - Registered Demonstrators only
- Individual companies are responsible for setup of their demonstration areas
- CEW will provide each entrant with a 3' by 2' area with white table linens for EACH product entry. Any branded table linens would come from the brand.



- All displays/risers, tester units, overlays, signs, floral arrangements etc. **MUST** fit within the provided space. Any exhibitor materials found to be infringing on common or other demonstrator space are not allowed. * *
- Storage is limited to the space underneath your table
- All entries may provide a small sign that identifies your product, product company & category for each entry, to be displayed in your designated area.
- Table-top promotional signage may also be included. Signs should be no larger than 12 inches tall in order to not block fellow Demonstrators.

* * NOTE: NOTHING IN YOUR SPACE MAY BE HIGHER THAN 12" IN HEIGHT TO PREVENT BLOCKING FELLOW DEMONSTRATORS! All items must fit on your tabletop and NO items are permitted on the floor in front of your space.

PRODUCT DEMO DO'S/DON'TS

DO:

- Provide applicators/towelettes, tissues and a trash can if you test your products. If water is needed for the testing and removal of your product, water can be brought and stored under your table space. Cleaning products from the same product line of the product being demonstrated may not be used.
- You may distribute or display posters, brochures, postcards or pamphlets about the product entered ONLY.
- You may use table overlays or flowers as part of your display. For Delivery Instructions, please refer to p. 10. (Flower display may not be higher than 12 inches tall) * *
- NOTE: We will measure all table top signage and floral arrangements to confirm that they adhere to these height restrictions. We will ask you to remove or cut any items that do not adhere to the restrictions.
- You may bring risers or containers to hold pamphlets or demonstration products (glass bowl, basket, or similar).
- You may display table-top posters, promotional signage, advertisements and tester units. (Signs may not be higher than 12 inches tall) * *
- You may bring items to demonstrate/test the product including:
 - Head with wig to demonstrate hair styling product
 - Scent strips, cotton balls, tissues, make-up remover etc.
- Small electronic devices may be used to visually enhance your display. Content must be relevant to the entered product only **without** the use of audio or music.
 - Electricity will not be available. Devices must be fully charged and should not rely on an electrical power source. (i.e. iPad, laptop, smartphones or tablets)
- Any perishable food used for display must be in a sealed container. All food preparation (i.e. cutting of fruit, etc.) must be done in advance.
- You may distribute small wrapped candy.

DON'T:

- Distribute product samples at your table (you may TEST products)
- Display free-standing/floor posters, promotional signage, or advertising. All signage must fit on your table and be no higher than 12 inches tall.
 - NOTE: We will measure all table top signage and floral arrangements to confirm that they adhere to these height restrictions. We will ask you to remove or cut any items that do not adhere to the restrictions.
- Distribute any bags with name of product or company (considered promotional).
- Have any candles or other open flames
- Bring displays requiring access to water sources. If water is needed for the testing and removal of your product, water can be brought and stored under your table space.
- Distribute cupcakes, cookies, popcorn, beverages etc. Only small wrapped candy will be permitted.

Please use your discretion. If a demonstrator's materials obviously infringes upon, stands out or otherwise detracts from other tables, or demonstrators use any other means of securing an unfair advantage, CEW staff will ask the demonstrator to put that item away under their table.
